ATJ – Enlightened Self-Interest: 10 Ways Pro Bono Helps You in Your Practice

BELLAIRE

This session will examine how pro bono work can support professional development while meeting community needs. It will cover programs like the State Bar of Texas' New Opportunities Volunteer Attorney (NOVA) initiative and legal aid partnerships, focusing on how these opportunities can help attorneys build skills, gain experience in new areas of law, and meet requirements for board specialization. Presenters will discuss practical ways to volunteer through clinics, law libraries, and virtual platforms, and how these experiences contribute to trial readiness and courtroom familiarity. The session will also address ethical considerations when litigating against pro se parties, time management in a busy practice, and best practices for hybrid legal work. Whether new to the practice or well-established, participants will leave with practical insights into how pro bono work supports both service and professional growth.

Local Bars – Austin Bar Foundation Lawyer Crisis Assistance Program ("CAP" Program)

POST OAK

The professional continuity of law practice, whether it is the practice of a solo practitioner or a law partnership, can be interrupted by an attorney's substance abuse, mental health challenges, physical illness, and other reasons. This program was developed as a pilot program in connection with various stakeholders in the legal community to fill the gap when the impacted lawyer needs to temporarily (up to 90 days) step away by providing valuable resources to attorneys seeking assistance through the program. Once the applicant's application is accepted into CAP, the program matches the attorney with volunteer lawyers in the same or similar practice area who are willing to temporarily assist with the impacted attorney's cases while the impacted attorney steps away to care for their mental and/or physical health. Prior to participation in the program, the impacted attorney must designate a custodian attorney with the State Bar of Texas, as well as grant the program permission to privately notify the courts in which the attorney has pending cases.


